The Installation Facilities Standards (IFS) program is part of the Air Force Corporate Facilities Standards (AFCFS) program; and assists bases in implementing and maintaining facilities standards as appropriate for efficient operations within the respective climate region.

What is the Army stationing & installation plan (ASIP)?

Army Regulation AR 5-18,the Army Stationing and Installation Plan (ASIP),provides guidance and procedures for the planning and programming of Army stationing actions. This includes the reassignment of units, activities, and individuals, as well as the arrangement of installations to support military forces effectively and efficiently.

What are installation planning standards?

Installation Planning Standards (IPS) capture the Installation's guidelines for development of sustainable and efficient facilities. The Standards provide a clear set of guidelines to ensure that the installation's Vision and planning Objectives for development are achieved. The Standards are applicable to all installation tenants.

What issuances address real property and installation management activities?

Additional installation management policies are set by each MILDEP, or the Office of the Secretary of Defense (OSD) for real property they manage.
