Should exports of electric energy be allowed?

Part II,Section 202 (e) of the Federal Power Act (FPA) states that exports of electric energy should be allowedunless the proposed export would impair the sufficiency of electric power supply within the U.S. or would impede or tend to impede the coordinated use of the U.S. power supply network.

#### How do they export electricity?

At the heart of electricity export lies a vast network of high-voltage power lines known as interconnectors. These cables, often running underground or under the sea, connect the national grids of two or more countries.

#### Can I export electric energy if I have a transmission line?

DOE must also comply with NEPA before granting authorization to export electric energy. However,in many instances DOE is able to cite a categorical exclusion(10 CFR 1021.410) for exports over existing international transmission lines. DOE encourages electronic submissions of applications for Export Authorization.

#### Do external power supplies have a power efficiency mandate?

At a global level,mandates for power efficiency exist for most consumer electronics and home appliances. External power supplies have had regulations dating back to 2004,when the California Energy Commission created one of the first mandates for efficiency of external power supplies used to power appliances or consumer electronic devices.

#### How do I get an electricity export authorization?

Export authorizations issued since 1995 authorize the last entity that holds title to electricity inside the United States to export the electricity using a specific transmission line or collection of lines. Requests for export authorizations not currently on the website should be addressed to electricity.exports@hq.doe.gov.

#### Do I need an export license?

U.S. Government rules, licenses, and other legal considerations may apply to your product or service. Before you export, you need to determine whether your product, technology, or service might need an export license.
