What is Article 85 of the French energy code?

Article 85 of the Climate and Resilience Act dated 22 August 2021 created Article L. 352-1-1 of the French Energy Code, which provides for the use of calls for tenders to develop electricity storage capacities. Decree n° 2022-788 of 6 May 2022 specifies how the tender mechanism will be implemented.

How much storage capacity does France have?

In 2015,France had 5.82 GWof operational storage capacity,of which pumped storage comprised 5.81 GW. However electro-chemical storage is growing rapidly,in particular with lithium-ion batteries, with batteries accounting for nearly 52 per cent of the remaining storage capacity.

What is France doing about battery storage?

France is working on reducing the barriers to the rollout of storageincluding the introduction of a legal framework, the simplification of the network connection rules, and the clarification of tax rules, with ambition to have a significant grid stabilising role of battery-storage in a horizon by 2030.

How does France manage security of electricity supply?

France has several mechanisms to manage security of electricity supply. A capacity mechanism commits capacity providers to make their generation or demand reduction available during consumption peaks; it includes 2.9 GW of demand side response.
