Will Italy support a centralised electricity storage system?

The European Commission has approved, under EU State aid rules a EUR17.7 billion Italian scheme to support the construction and operation of a centralised electricity storage system.

What are Italy's energy storage goals?

Energy Storage Goals: To balance the grid with increased renewable energy, Italy targets 11 GW /58 GWhof grid-scale energy storage capacity by 2030, requiring substantial investment and development.

How much energy storage capacity does Italy have?

As of November 2024 Italy had 5.1 GW/11.7 GWh of energy storage capacity. This is almost exclusively small-scale residential system, with utility-scale storage systems providing just 864 MW. To help achieve the target for utility-scale storage build-out, the Italian government has implemented the MACSE subsidy scheme as supporting legislation.

Is Italy a leader in industrial energy storage and commercial energy storage?

Accordingly, there is a growing market for industrial energy storage and commercial energy storage projects, positioning Italy as a leaderin advanced Italy storage solutions and renewable energy Italy initiatives.

How much will Italy invest in utility-scale storage?
