

Does telecommunications equipment need to be type approved in Kiribati?

Telecommunications equipment brought into Kiribati will need to be type approved if the specific type of equipment is not listed on the Communications Commission of Kiribati (CCK) Type Approval Register on its website. All telecommunications equipment brought into Kiribati will be subject to license fees.

Vodafone Kiribati and Ocean Link both have mobile and internet coverage in Tarawa and Christmas Island. Smaller internet service providers include Speed Wave, Tentanini, and TeniCom, to name a few. The former Telecommunication Authority of Kiribati has a new change of name under the new ACT and the new name now is Communications Commission of Kiribati. The Commission's main core function will regulate communications service providers and the use of the radio spectrum in Kiribati.

Does Kiribati have an individual license?

There are only two providersin Kiribati who comply with the requirements for an individual license - Vodafone Kiribati (referred to as ATH in previous LCA) and Ocean Link. Individual licenses authorize the ownership or operation of any specified communications network and the provision of any communications service.
