

# Kyrgyzstan Customs Energy Storage Container

#### Can citizens of Kyrgyzstan import household items?

Citizens of Kyrgyzstan may import household effects on permanent import basis only, thus are liable to pay all customs charges in full. Temporary import - possible for items imported temporarily maximum for 2 years. For temporary import only customs fee is paid at once prior to customs clearance process.

#### What is the difference between permanent and temporary import in Kyrgyzstan?

permanent import - whole amount of import customs charges is paid at once prior to import customs clearance process. Citizens of Kyrgyzstan may import household effects on permanent import basis only, thus are liable to pay all customs charges in full. Temporary import - possible for items imported temporarily maximum for 2 years.

#### What are the import and export procedures in Kyrgyzstan?

The management of import and export procedures in Kyrgyzstan is governed by specific regulationsthat designate certain goods as prohibited or restricted. Prohibited goods are items that cannot be imported or exported under any circumstances, while restricted goods may be subject to specific conditions or limitations.

#### What are the customs procedures in Kyrgyz Republic?

Standard procedures of customs clearance and customs control of goods and vehicles crossing the border of the Kyrgyz Republic, as well as the list of documentation and other requirements for the successful importation of products into the Kyrgyz Republic, are outlined in the Customs Documentation page of the EEC.

#### Can I import a car to Kyrgyzstan?

They must conform to Euro 5 standard. Right-side vehicles are prohibited for importto Kyrgyzstan. All vehicles are subject to certification (except for diplomatic vehicles). Beside customs charges (duty,fee,VAT) some vehicles are subject to also excise- duty as per customs tariff (see details below).

Government websites, such as the State Customs Service of Kyrgyzstan, provide comprehensive information on restricted items. Moreover, consulting with legal experts or customs brokers can offer additional guidance.
