How much do lithium ion batteries exports cost?

The overall value of lithium ion batteries exports increased by an average 31.7% for all exporting countries from five years earlier in 2020 when lithium ion batteries shipments were valued at \$2.71 billion. Year over year, revenues from exported lithium ion batteries accelerated by 52.4% compared to \$3.5 billion during 2023.

Which countries export lithium ion batteries?

Year-over-year, revenue from these exports saw a modest increase of 1.7% in 2022 compared to \$3.21 billion in 2021. The top five exporters of lithium ion batteries were the United States, mainland China, Singapore, Hong Kong, and Indonesia. Combined, these countries accounted for over half (55.2%) of the global lithium ion battery exports in 2022.

What are the shipping requirements for lithium batteries?

Some general shipping requirements to transport lithium batteries internationally include: Lithium batteries weighing over 35kg must be approved by the national authority of the shipping and destination country before shipment. Defective or damaged lithium batteries must not be transported.
