The UK is a step closer to energy independence the government launches a new scheme to help build energy storage infrastructure. This could see the first significant long duration electricity storage (LDES) facilities in nearly 4 decades, helping to create back up renewable power and bolster the UK's energy security.

While the government response did not commit it to providing a full energy storage strategy, it has promised to design, by 2025, a new business model for hydrogen storage infrastructure and how best to enable private sector investment and remove market barriers.

What is the future of energy storage in the UK?

The UK's energy storage market continues to experience strong growth. In 2024, operational capacity of energy storage resources was 4.6 GW/5.9 GWh, which was projected to increase to 7.4 GW/11.6 GWh by the end of 2024. Moreover, the future looks promising, with total planned capacity for energy storage projects of 85 GW/175 GWh.

Could long duration electricity storage be the UK's first energy storage facility?

This could see the first significant long duration electricity storage (LDES) facilities in nearly 4 decades, helping to create back up renewable power and bolster the UK's energy security. These technologies work like giant batteries by storing renewable energy and releasing it onto the grid and into homes when needed.

Should the government publish an energy storage strategy by 2025?

A further recommendation posted in the EAC's report was for the government must publish an energy storage strategy by the end of 2025to indicate the capacity and type of both short-term and long-term energy storage which will be required in a net zero energy system.
